## 2. Council Member Reports

**Council Member Weissenfels** reviewed a report prepared by Karen Beyer on Friends of Forks Animals activities since September 2020.

## 3. Staff Reports

Attorney/Planner Fleck reported that anglers have a hearing with the Senate Agriculture, Water, Natural Resources & Parks Committee regarding the new Washington Department of Fish and Wildlife steelhead fishing rules tomorrow. They also have other meetings and hearings with concerned departments and committees. The City has retained an attorney experienced with matters like this to help, and Attorney/Planner Fleck is advising them on what to ask for, how to ask for it, what to prepare, prepping them for their hearings, and so on.

The City EOC crew met with hospital staff regarding COVID-19 vaccination clinics that will be held from 10:00 a.m. to 3:00 p.m. on Fridays and Saturdays for the foreseeable future. At this point, those aged 70 and older, and those 50 and older living in a household with one or more people aged 70 or older, qualify for vaccination. Vaccinations will be given in the auxiliary gym at the high school, with the Transit Center and Peninsula College parking lots used as holding areas. Forks has vaccinations for the entire West End with the exception of the Quileute and Makah Tribes and Department of Corrections, all of whom have or are handling their own vaccinations.

# 4. Mayor's Report

Mayor Fletcher recognized City staff and the EOC for their leadership throughout the entire COVID-19 pandemic. He also acknowledged Heidi Anderson and the hospital staff, and Diana Reaume and Bill Henderson at Quillayute Valley School District, as just some who have worked behind the scenes to get us through these difficult times. The combined efforts show how we can all work together to get through a pandemic or even catastrophe, and gives him great hope for, and pride, in our community.
