The total amount billed for April 1 through June 33, 2024 was \$25,311.70. The total amount billed for April 1 through June 30, 2023 was \$40, 381.33.

### Community Service, Work Release, Trustee Hours

An inmate who is eligible for Community Service earns additional time off their sentence for good behavior and has the freedom to work with Public Works personnel outside of the Jail. They are housed in a trailer behind the Jail as a reward. The trailer has ten bunks, a bathroom with shower, flat screen TV and microwave. They are also allowed to go outside within the fence line where they can play basketball during their off hours. Other inmates housed in the trailer are Work Release Inmates and Jail Trustees.

Between April 1 and June 30, 2024 trustees assisted Public Works personnel with 216 total man hours. Between April 1 and June 30, 2023 trustees assisted Public Works personnel with 880 total man hours.

Eligible inmates pay \$15.00 per day for the privilege of Work Release. Three subjects were on Work Release for the period April 1, 2024 through June 31, 2024. One subject worked 91 days at \$15 dollars a day for a total of \$1,365.00. Thee secound subject worked 30 days at \$15 dollars a day for a total of \$450.00. The third subjusted worked 10 days at \$15 dollars a day for a total of \$150.00 dollars. One subject was on work release during the period January 1, 2023 through March 31, 2023. This subject worked for a total of 43 days at \$15.00 dollars a day for a total of \$645.00 dollars. This program allows eligible inmates to maintain their job while serving their sentence. There is no credit for good behavior on this program.

### Order Declaring Unusual Fire Danger and Imposing Burn Ban in the City of Forks

Pursuant to Forks Municipal Code Chapter 2.35, as the City's Fire Inspector so designated by the Mayor, and in order to avoid any uncertainty, we hereby declare that there is an unusual fire danger in the City of Forks. This is based upon the following:

- 1. Warm summer heat and winds; and
- 2. Lack of rainfall being predicted for the next seven to ten days.

Combined, these conditions will increase the potential of grass, leaves, and other plants to catch on fire.

Further, pursuant to the authority within that Chapter, and with the full concurrence of the Mayor, I <u>hereby absolutely prohibit</u> the use of fire within the City of Forks; **EXCEPT FOR**, recreational fires in self contained fire pits, smokers, bar-b-ques (briquette or propane).

I also hereby prohibit the use of such things as "Japanese Lanterns" (floating lanterns), open fire pits, and the use of fire torches of any kind for treatment of yards, driveways, etc. Additional modifications may be made to ensure the public's safety. This ban on the use of fire shall remain in effect until such time as the Clallam County Fire Marshall, or their designee, removes the concurrent Clallam County Fire Ban.


